Soft gelatin capsule

Carefully read the entire package insert, as it contains important information for you. CENTRUM® OMEGA 3 is available without a doctor's prescription for you to use as a health supplement. Nevertheless, you must still use CENTRUM® OMEGA 3 with care to get the best results from it.

- Do not share CENTRUM® OMEGA 3 with anyone else.
- Ask your pharmacist if you need more information or advice.
- You must consult a doctor if you experience worrying symptoms.

WHAT CENTRUM® OMEGA 3 CONTAINS:

The active substances are as follows:

Ingredients:	Each MiniGel contains
Total omega 3	366 mg
EPA (eicosapentaenoic acid)	220 mg
DHA (docosahexaenoic acid)	110 mg
Other omega 3	36 mg

The other ingredients are: Canola oil, citric acid, gelatin (bovine), glycerine, purified water, sunflower oil, tocopherols and natural taste agent.

WHAT CENTRUM® OMEGA 3 IS USED FOR:

CENTRUM® OMEGA 3 is a rich source of essential fatty acids that cannot be produced by the body and must, therefore, be ingested via a healthy diet and supplements to support good health and nutrition.

EPA (eicosapentaenoic acid) and DHA (docosahexaenoic acid) are concentrated forms of omega 3 that appear in oceanic fish living in cold water. These omega 3 fatty acids are essential for the body and play a role in the support of cardiovascular, eye and brain health. The role of each ingredient in CENTRUM® OMEGA 3

EPA (eicosapentaenoic acid) – EPA in your diet may be beneficial for the cardiovascular system and can reduce inflammation.

DHA (docosahexaenoic acid) – DHA supports brain health of adults and eye health.

BEFORE YOU TAKE CENTRUM® OMEGA 3:

Do not take CENTRUM® OMEGA 3:

- if you are hypersensitive to DHA, EPA or any of the ingredients in CENTRUM® OMEGA 3.

Take special care with CENTRUM® OMEGA 3:

- if you are using other supplements. Read the label, as these supplements may contain the same ingredients.
- In case of an overdose, consult your doctor or pharmacist. If neither of them is available, get help from your closest hospital or poison control centre.
- if you suffer from a medical condition or take medication, consult your doctor before use.
- Consult your doctor if you are taking any other EPA/DHA supplements, aspirin or anticoagulants (e.g. warfarin) as your bleeding time can change.

Pregnancy and breastfeeding:

If you are pregnant or breastfeeding your baby, please consult your healthcare provider for advice before using CENTRUM® OMEGA 3

Driving ability and the use of machines:

HOW TO TAKE CENTRUM® OMEGA 3:

Take CENTRUM® OMEGA 3 as below or as indicated by your healthcare provider.

The usual dose is:

Adults: 2 MiniGel capsules daily with food.

Not formulated for use by children.

It is not recommended to exceed the daily dose.

Nutritional supplements cannot replace a balanced diet.

If you take more CENTRUM® OMEGA 3 than you should:

In case of an overdose, consult your doctor or pharmacist. If neither of them is available, contact the closest hospital or poison control centre.

If you forget to take CENTRUM® OMEGA 3:

Do not take a double dose to compensate for a missed dose.

POSSIBLE SIDE EFFECTS:

CENTRUM® OMEGA 3 can cause side effects:

Not all side effects reported for CENTRUM® OMEGA 3 are included in this package insert. Should your general health deteriorate, or if you develop any unwanted effects while you are taking CENTRUM® OMEGA 3, please consult your healthcare provider for advice.

Store all medicine out of reach of children.

Store at or below 25 °C in a cool, dry place.

Keep the container tightly closed.

Do not store in a bathroom.

Do not use after the expiry date as furnished on the bottle's label and cardboard container.

Give all unused medicine back to your pharmacist.

Do not dispose of unused medicine in drains or sewerage systems (e.g. toilets).
